Monthly Revenue Update



January 2025

In June 2024, the Independent Fiscal Office (IFO) released revenue projections for fiscal year (FY) 2024-25. January General Fund collections of \$3.92 billion were \$13 million (-0.3%) lower than the IFO's official estimate. (The IFO estimate for January was \$38 million lower than the administration's official estimate.) Fiscal-year-to-date (FYTD) collections total \$24.10 billion, \$70 million (+0.3%) more than the IFO estimate. Compared to the prior year, January collections were \$16 million (+0.4%) higher and FYTD collections are \$346 million (+1.5%) greater than the prior year. Revenue highlights include:

- Personal income tax (PIT) collections for January totaled \$1.96 billion, \$102 million (+5.5%) above the prior year. FYTD collections are meeting estimate. Withholding revenues were \$1.30 billion, \$48 million (-3.5%) below estimate and \$35 million (+2.8%) more than the prior year. FYTD collections are \$35 million (+0.4%) above estimate. Compared to January 2024, non-withholding payments increased \$67 million (+11.4%). FYTD collections are \$38 million (-2.0%) below estimate.
- Monthly corporate net income tax (CNIT) collections of \$194 million were \$14 million (+7.7%) above estimate and \$17 million (-7.9%) below the prior year. FYTD CNIT collections of \$2.71 billion are above estimate by \$50 million (+1.9%).
- January sales and use tax (SUT) collections were \$1.35 billion, \$29 million (+2.2%) higher than the prior year.
 Non-motor vehicle collections were \$1.24 billion, \$6 million (+0.5%) higher than projected and \$27 million (+2.2%) above the prior year. Monthly motor vehicle collections of \$105 million were below estimate by \$1 million (-0.8%) and \$2 million (+1.7%) greater than last January. FYTD SUT collections of \$8.67 billion are meeting estimate.
- Treasury collections (adjusted for a one-time unusual deposit last year) declined \$22 million (-40.6%) in January, as interest rates and the General Fund balance continue to decline.
- Monthly licenses and fees collections exceeded estimate by \$24 million due to delayed deposits from December. FYTD collections through January are \$16 million (-20.4%) below estimate.
