Dear Senator Tomlinson:

This letter responds to your request that the Independent Fiscal Office (IFO) provide an update to a previous letter transmitted by the office regarding estimates of the funds necessary for a proposed expansion of the Property Tax Rent Rebate (PTRR) program for certain homeowners.¹

Your updated request specified certain parameters of the proposal that are relevant to the estimates:

- Establish a new base rebate of \$175 for all senior homeowners with household incomes between \$35,000 and \$50,000.
- Expand the supplemental rebates given to senior homeowners who meet certain income and property tax burden requirements. Specifically, the proposal would increase the household income limit for a supplemental rebate from \$30,000 to \$50,000 and decrease the property tax burden threshold from 15 percent to 10 percent.
- For homeowners not located in Pittsburgh, Philadelphia or Scranton, your letter requests estimates for two proposals related to the supplemental rebate: (1) increase the supplemental rebate to \$1,500 and (2) increase the supplemental rebate to \$2,000. Homeowners located in the aforementioned cities would receive supplemental rebates that range from \$1,175 to \$1,500 and \$1,675 to \$2,000, respectively in each proposal.
- Total rebates may not exceed property tax paid.

Based on these parameters, the analysis finds the following results for increasing the supplemental rebate to \$1,500:

- The new base rebate for household incomes between \$35,000 and \$50,000 would result in 68,600 new rebates (\$12.0 million).
- The new supplemental rebate for household incomes between \$35,000 and \$50,000 would result in 24,900 new rebates (\$37.3 million).

- The expansion of the supplemental rebate for homeowners currently eligible for a base rebate would impact 193,013 homeowners through new or higher supplemental rebates (\$215.5 million).
- The expansion of the supplemental rebate for homeowners with income of \$35,000 or less is projected to incentivize 124,400 new filers (\$206.6 million). These filers would receive a base and supplemental rebate.
- The total estimated increase in rebates paid under the \$1,500 supplemental rebate proposal would be \$471.4 million.

Based on these parameters, the analysis finds the following results for increasing the supplemental rebate to \$2,000:

- The new base rebate for household incomes between \$35,000 and \$50,000 would result in 76,300 new rebates (\$13.4 million).
- The new supplemental rebate for household incomes between \$35,000 and \$50,000 would result in 27,800 new rebates (\$55.6 million).
- The expansion of the supplemental rebate for homeowners currently eligible for a base rebate would impact 193,013 homeowners through new or higher supplemental rebates (\$271.9 million).
- The expansion of the supplemental rebate for homeowners with income of \$35,000 or less is projected to incentivize 171,400 new filers (\$345.2 million). These filers would receive a base and supplemental rebate.
- The total estimated increase in rebates paid under the \$2,000 supplemental rebate proposal would be \$686.1 million

The first group of homeowners affected by the proposals are those with household income between \$35,000 to \$50,000. This group of homeowners is currently ineligible for any type of rebate under the PTRR program. Under the proposal, all homeowners in this income range would be eligible for a new base rebate of \$175. According to data from the American Community Survey, there are an estimated 152,500 homeowners in Pennsylvania that would be newly eligible for the base rebate as a result of this expansion. Table 1 (next page) displays the impacts from the higher income threshold.

² This estimate consists of homeowners in which the reference person is age 65 or over, with household income between \$35,000 and \$50,000. Household income was adjusted to be consistent with the PTRR Social Security income adjustment. Social Security income for all households was reduced by 50 percent to establish newly eligible households.

If all newly eligible homeowners received a \$175 rebate, then there would be 152,500 new base rebates, worth \$26.7 million. However, survey data for 2017 suggest that there were an estimated 470,000 eligible homeowners with \$35,000 or less in income and a householder age 65 or over. These homeowners would have been eligible for at least the base rebate based on income and age, but PTRR data suggest that approximately 60 percent of those homeowners filed.

For the purpose of the analysis, the following assumptions were made:

- For the \$1,500 supplemental, the analysis assumes that 68,600 (45 percent) of homeowners newly eligible for at least a base rebate will file (\$12.0 million). Moreover, 29,300 homeowners would be newly eligible for the supplemental rebate, and the analysis assumes that 24,900 (85 percent) would file (\$37.3 million). The overall utilization rate for all new filers is then a weighted average of homeowners that receive a base rebate only (35 percent) and homeowners that also receive a supplemental rebate (85 percent).
- For the \$2,000 supplemental, the analysis assumes that 76,300 (50 percent) of homeowners newly eligible for at least a base rebate will file (\$13.4 million). Moreover, 29,300 homeowners would be newly eligible for the supplemental rebate, and the analysis assumes that 27,800 (95 percent) would file (\$55.6 million). The overall utilization rate for all new filers is then a weighted average of

homeowners that receive a base rebate only (40 percent) and homeowners that also receive a supplemental rebate (95 percent).

Table 2 details the impact on the second group of affected homeowners under the \$1,500 supplemental rebate proposal. This group includes households with incomes of \$35,000 or less that are already eligible for rebates under the current program. There are three subgroups in this income range: (1) filers that received a supplemental rebate but will now receive a larger one, (2) filers that received a base rebate but were ineligible for a supplemental rebate due to the income or tax burden thresholds, but will now receive a supplemental rebate and (3) a new group of homeowners that previously did not file for any type of rebate, but will now be incentivized to file due to the larger supplemental rebate. These filers receive both a base and supplemental rebate.

The proposed expansion would impact 193,013 current filers with income of \$35,000 or less. This figure includes (1) homeowners that are newly eligible for a supplemental rebate and (2) homeowners that would receive a higher supplemental rebate. Among the total impacted, 70,756 homeowners would receive new rebates. These homeowners were previously ineligible because they didn't meet the household income or property tax burden requirement. When combined with currently eligible homeowners that receive an increase in their supplemental rebate, total rebates increase by \$215.5 million. The average increase in supplemental rebates for this group of homeowners is \$1,116.

This analysis assumes that the utilization rate for senior homeowners with household income below \$35,000 increases from 60 percent to 85 percent, and the larger supplemental rebate incentivizes 124,400 new filers. The new group of filers will be eligible for the base and supplemental rebates, increasing rebates by an estimated \$206.6 million.

Table 3 displays the same data, but for the version of the proposal that increases the supplemental rebate to \$2,000. The combination of currently eligible homeowners that receive an increase in their supplemental rebate and newly eligible homeowners increases total rebates by \$271.9 million. The average increase in supplemental rebates for this group of homeowners is \$1,409. The analysis for this version assumes that the utilization rate for homeowners with household income below \$35,000 increases from 60 percent to 95 percent, and the larger supplemental rebate incentivizes 171,400 new filers. The new group of filers will be eligible for the base and supplemental rebates, increasing rebates by an estimated \$345.2 million.

Under the proposal, the increase in rebates provided would be funded by current Act 1 allocations that are distributed to school districts. The table that follows provides the estimated reduction in Act 1 allocations for each school district necessary to fund the \$1,500 version of the proposal. The estimated impact was calculated by pro-rating the school districts' allocations down by the ratio of total funds necessary to total current Act 1 allocations. Specifically, each school district's allocation was reduced by 76.0 percent (\$471.4 million / \$620.5 million). Due to the funds necessary for the \$2,000 version of the proposal being greater than total Act 1 allocations, no impact is shown for that scenario. That version would require all Act 1 allocations plus an additional \$66 million to fund the proposal.
